Organization Description: Advocates for Urban Agriculture (AUA) is a coalition of urban farms, community and school gardens, individuals and businesses working to empower urban growers to foster thriving communities through sustainable agriculture and equitable food systems.

Position Description: The Community Outreach Specialist will help AUA operationalize our values and strategic directions by strengthening existing relationships and cultivating new ones with individuals and community partners across multiple sectors. Building on these relationships, the Community Outreach Specialist will support social media content, advocacy, and program initiatives.

Primary responsibilities:

- Support AUA's existing program and advocacy initiatives, including Ward Ambassadors and Good Practices for Growing In Chicago.
- Proactively build relationships with new and existing community partners across multiple sectors connected to urban agriculture.
- Support the implementation of a social media marketing plan.
- Promote the work of partner organizations across multiple sectors on AUA's social media accounts Instagram, Facebook, and Twitter as well as our website.

• Support AUA's listserv and newsletter communications by researching and collecting resources, including upcoming workshops, events, funding opportunities, etc.

Primary Qualifications:

- A strong commitment to AUA's mission, values, and strategic directions.
- A minimum of 2 years of community advocacy experience, including familiarity with campaigns.
- A minimum of 2 years of experience in urban agriculture, food systems, or other community focused areas.
- A minimum of one year of experience creating and posting content on social media platforms for a business/organization.
- Experience facilitating community meetings and group discussions.
- Excellent relationship and coalition building skills.
- Excellent verbal and written communications skills, with the ability to communicate in more than one language.
- Strong organizational skills, with a proven ability to manage multiple projects.
- Proven ability to work independently and meet deadlines.

Preferred Qualifications

- Bachelor's Degree in a relevant field.
- Strong familiarity with urban agriculture and local food movements in the Chicago region.
- Experience with curriculum development, specifically in the field of political education.
- Bilingual skills
- Comfortable using multiple social media platforms and post scheduling applications.
- Other marketing and communications experience, including graphic design, word press, etc.

Physical Demands:

- Employee to work primarily from home, with regular visits to local farms, gardens, and community organizations.
- Requires ability to use computers, telephones, and other office equipment.
- Requires ability to speak audibly and listen actively.
- Requires ability to use a computer for an extended period of time.
- Will require periodic travel.

Compensation: This position is part-time, exempt, and at-will. The compensation for this position is set at \$22,500 at 20 hours/week for one year, formally ending in June 2022, with a limited benefits package, and potential for growth within the organization.
